Case Study

HARMONiQ and Monkeytoe – managing manufacturing through rapid growth

How does a family business scale and achieve long-term success through systematizing processes? For aluminium manufacturer Monkeytoe, implementing HARMONiQ turned out to be the ideal solution.

The Taranaki-based company designs, manufactures and installs aluminium structures across New Zealand. Looking to expand, it needed a system to help streamline and optimise multiple elements of the business – from stock costings and quotes to management, scheduling, progress claims and invoicing.
